RACE SANCTIONING: \$25.00 US for each class or 1 (one) % of the purse, whichever is greater, up to a maximum of \$250 US per event.

CLUB MEMBERSHIP FEE: The Club or RGO must be a member of ISDRA to apply for sanctioning. \$100 US annually.

Sanctioning fees are non-refundable except when an event is canceled due to weather conditions. A sanctioning fee credit of all but \$25.00 will be on file for use in the next sanctioning year, excluding postage, advertising and insurance costs.

APPLICATION DEADLINES: Sanctioning applications should be submitted (postmarked) 45 days prior to the event. A late fee of \$25.00 will be charged for all applications postmarked/received less than 45 days prior to the event. Sanctioning applications not postmarked at least 30 days prior to the first day/heat of the event may be rejected. **All sanctioning fees must be paid in U.S. funds.** Applicants in countries other than the United States are advised to use international money orders.
